An important component of this program is the certification exam known as the CIP (Certified IRB Professional). This examination which is offered twice a year covers a wide range of regulatory topics. The book addresses the key issues in federal regulations outlined in statutes

including Title 45 part 4 (Protection of Human Subjects) , Title 21 part 50 (Protection of Human Subjects), Title 21 part 56 (Institutional review Boards) Title 21 part 54 (Financial Disclosures by Clinical Investigators) .
